2. 6315 W. HUCKLEBUCK LANE, EDINBURGH - STARLIT PATH, LLC IS REQUESTING TO REZONE 14.76 ACRES (4 LOTS) FROM RE TO A4 (AG COMMERCIAL), THEY ARE GOING TO BUILD A WEDDING BARN. MOTION TO APPROVE ORDINANCE 2017-13 WAS MADE BY PARKER, SECONDED BY ROSS, APPROVE 3-0
