

The Shelby County Commissioners met on Monday June 10, 2024, at 8:00 a.m., present were Commissioners, Nigh, Parker, Abel, County Attorney and County Auditor.

**MINUTES:**

Motion to approve June 3, 2024, minutes was made by Nigh, seconded by Abel, approved 3-0.

**COUNTY ROAD TRUCK ORDINANCE:**

Commissioner Abel advised the county has been seeing a lot more Commercial Truck Traffic on the County Roads. This Ordinance will be setting size to 50 feet and weight limits of 26,000 for the county roads no marked with signage identifying the road as a truck route. Exceptions to the prohibited operation of heavy truck through traffic shall include agricultural vehicles, farm equipment or farm implements owned and or operated by residents of Shelby County transporting grain or other agricultural products to elevators or other storage facilities within the County, fire and other emergency vehicles, state, county or private road construction traffic that are making repairs or maintaining roads in the County, local deliveries, garbage or other public or private utility company vehicles while servicing locations within the County, and vehicles owned or operated by citizens of the County necessary to travel to and from their place of residence or employment. Motion to approve Ordinance 2024-06 was made by Abel, seconded by Nigh, approved 3-0.

**911 DIRECTOR RECOMMENDATION/911 OPERATIONS BOARD:**

Sheriff Koch advised the 911 Operations board has recommended the hiring of Tisha Debaun as the new Director of E911. Motion to approve was made by Nigh, seconded by Abel, approved 3-0.

**PLAN COMMISSION / 2 REZONES & ORDINANCE AMENDMENT:**

Desiree presented two rezones:

1. Devin Law is requesting to rezone 5.94 from A1 to RE, located on the East side of Sand Creek Rd ¼ mile south of C 100 N This was heard under Plan Commission 24-3 and heard at the May 28,2024 meeting and voted 6-0 to present to the Commissioners for approval. Motion to approve Ordinance 2024-07 was made by Nigh, seconded by Abel, approved 3-0.
2. Keith Hockett is requesting to rezone 1.082 acres from A4 to R1 located @ 5542 w 1100 N. This was heard under Plan Commission 24-4 on May 28, 2024, meeting and voted 6-0 to present to the Commissioners for approval. Motion to approve Ordinance 2024-089 Abel, seconded by Nigh, approved 3-0.

Desiree presented Ordinance 2024-9 amending the Unified Development Tax Amendment Specifically Floodplain Development Standards, this will modify Section 5.0 Article II. Motion to approve the changes was made by Nigh, seconded by Abel, approved-0.
