

## **THE SHELBY COUNTY COMMISSIONERS**

**MAY 5, 2025**

The Shelby County Commissioners met on Monday May 5, 2025, at 8:00 a.m., and present were Commissioners Abel, Lawson, Runnebohm, County Attorney and Deputy Auditor.

### **MINUTES:**

Motion to approve April 28, 2025, minutes was made by Lawson, seconded by Runnebohm, approved 3-0.

### **PURDUE EXTENSION / POSTAGE METER CONTRACT :**

Diana Stone presented the Commissioners with a 5-year contract with Quadient Leasing for their postage meter. The contract is \$82.06 per month which is less than before. Motion to approve the contract was made by Lawson, seconded by Runnebohm, approved 3-0.

### **PLAN DIRECTOR/ REZONES:**

Desiree presented the with the following two rezone requests:

1. Stephenson rezone of 1.208 acres from RE to VR located south and adjoining 4372 S Smithland Rd, Shelbyville, Hendricks Township. This was heard by the Plan Commission at the April 22, 2025, meeting and voted on 6-0, to forward to the Commissioners for approval. There was lots of discussion about the standing water and flooding that occurs in this area. The owner plans to collaborate with the Surveyor to make sure this is done correctly. Motion to approve Ordinance 2025-09 was made by Lawson, seconded by Runnebohm, approved 3-0.
2. Vest rezone of 1.49 acres from RE to R1 is located at 7764 N 625 E, Shelbyville, Hanover Township. This was heard by the Plan Commission at the April 22, 2025, meeting and voted on 6-0, to forward to the Commissioners for approval. This is a one lot simple subdivision for a new house. Motion to approve Ordinance 2025-10 was made by Abel, seconded by Lawson, approved 3-0.

### **COUNTY AUDITOR/ 2025 COST ALLOCATION PLAN CONTRACT:**

County Auditor presented the Commissioners with the 2025 Cost Allocation Plan Contract with Maximus. This is a 3-year contract in the amount of \$5,600.00 per year. Motion to approve was made by Lawson, seconded by Runnebohm, approved 3-0.
