The Shelby County Commissioners met on Monday June 9, 2025, at 8:00 a.m., and present were Commissioners Abel, Lawson, Runnebohm, County Attorney & County Auditor.

**MINUTES:**

Motion to approve minutes from June 2, 2025, was made by Lawson, seconded by Runnebohm, motion passes 3-0.

**SHELBY COUNTY DEVELOPMENT CORPORATION / UPDATE:**

Brian Asher with the Shelby County Development Corporation wanted to give the Commissioners an update on development in Shelby County. Asher advised they have a new company coming in called Gifu Food Plastics, they are investing over 50 million dollars and will employ around 35 employees. We are currently working on filling requests from about 100 different requests. Asher also wanted to request their annual funds that they usually receive from the county in the amount of \$100,000.00. Motion to table until next week was made by Abel, seconded by Runnebohm, approved 3-0.

**SHELBY GO/ 2025 FISCAL YEAR GRANT:**

Easter Hall-Beyer came before the commissions because the Commissioners approved the 2025 Fiscal Year Grant, but the form had the wrong year on it, so the state sent out a new grant for to be signed. No action as needed.
