MINUTES:

LETTER OF FINANCIAL COMMITMENT CCMG 2024-1:

Ben Taylor with the Highway Department presented the Commissioners with a Financial Commitment Letter for the CCMG 2024-1 Grant. Taylor advised this grant will be for Bridge #30 over little Blue River on Union Road and the estimated cost to the county will be \$135,785.00. Motion to approve was made by Nigh, seconded by Abel, approved 3-0.

The other project is for Bridge #58 on Blue Ridge Road, estimated County cost will be \$197,292.00. Motion to approve was made by Nigh, seconded by Abel, approved 3-0.

SOLAR MORATORIUM EVALUATION:

The Commissioners advised the current moratorium on their Solar Plan is set to expire on January 31, 2024 with Ordinance 2023-28. They are working on the current plan and finding for things they need to tidy up and presented Resolution 2024-3, this will extend the moratorium until July 31, 2024 giving the Commissioners more time to clean things up. Hoosier Fiber Networks/Gudenkauf is requesting to install 2 risers & 335 feet of aerial strand along the N. Harrison St. Bridge. Motion to approve was made by Nigh, seconded by Abel, approved 3-0.

CenterPoint Energy is requesting to replace a gas service at 2652 S. Miller Ave., motion to approve was made by Nigh, seconded by Abel, approved 3-0.

SHERIFF:

Sheriff Koch advised the warranty on the underground fuel tank for the Generator's is do to expire. Koch advised he is looking to have this replaced with an above ground tank. Koch advised they will still have to take care of the tank underground and have it cleaned out and filled with sand. Koch advised he will be able to pay for this out of his budget.
