MINUTES:

Motion to approve February 26, 2024, minutes was made by Abel, seconded by Parker, approved 2-0-1 (Nigh).

COUNTY CLERK / POLLING LOCATIONS:

Jill presented the Commissioners with the 10 Polling Locations for both the Primary Election and the General Election. West Street Methodist Church, Mt. Pisgah Baptist Church, Intelliplex Conference Center, Fairland Town Hall, Morristown United Methodist Church, St. George Lutheran Church, Waldron Church of the Risen Christ, Moral Township Fire Station, Crossroad Community Church, Shelby County Fairgrounds. Motion to approve was made by Nigh, seconded by Abel, approved 3-0.

HWY DEPT. / BRIDGE INSPECTION CONTRACT:

Ben Taylor Assistant Supervisor with the Highway Department presented the Commissioners with the Shelby County Bridge Inspection Contract with USI. The total Contract is in the amount of \$378,520.00 and we will get reimbursed by the State for 80% of that amount - \$302,816.00. Motion to approve was made by Abel, seconded by Nigh, approved 3-0.

Donna presented the Commissioners with addendum #1 on the contract to help with the process of hiring a new E-911 director. The price will be \$150.00 per hour. Motion to approve was made by Nigh, seconded by Abel, approved 3-0.

Commissioner Abel made a motion to table until next week, seconded by Parker, approved 3-0

UTILITY REQUEST:

- 1. BMS Groups is requesting to bore along Southeaster Ave., near 12345 Southeastern Ave., motion to approve was made by Abel, seconded by Nigh, approved 3-0.
- 2. Kimley-Horn for Primoris Renewable Energy is requesting to do nine borings between the area of 500 E and 775 E and between 750 N and 500 N. Motion to approve was made by Abel, seconded by Nigh, approved 3-0.
