## SCDC/BRIAN ASHER/ YEARLY UPDATE:

Brian Asher with the Shelby County Development Corporation presented the Commissioners with an annual update and to request their annual payment of \$100,000.00. Asher advised this amount is up from last year of \$85,000.00. Asher advised in 2023 and so in 2024 there has been more than \$633,970,000.00 in investments in Shelby County, most of this is from the Bunge Expansion in the amount of \$500,000,000.00, POET with an expansion of \$1,000,000.00. There are a few smaller projects that are going on. Asher then spoke of the READI Grant 1.0 that was given last year and the projects they are using the money on like Early Learning Center, the Sports Complex and the Group will receive another \$30,000,000.00 for Phase 2.0. They are also looking at a Lilly Grant to bring more money in to help offset the cost of these projects. Motion to approve the 2024 funding of \$100,000.00 was made by Nigh, seconded by Abel, approved 3-0.
