MINUTES:

Motion to approve January 27, 2025, minutes was made by Lawson, seconded by Runnebohm, approved 3-0.

VEREGY/ RICK ANDERSON- ENERGY ASSESSMENT:

Rick Anderson with Veregy would like to help the County save money and would like to do an energy assessment on all of the county buildings. There is no cost to the county for the assessment. Anderson advised they have been working with the City of Shelbyville and have saved them above and beyond what they said they would be saving. They have also been working with Hamilton County. The Commissioners asked how long it would take to get the assessment back; Anderson advised it would be 6-8 weeks. The Commissioners would like to take under advisement and asked Anderson to send them examples of the contract and RFQ's. Motion to table was made by Runnebohm, seconded by Lawson, approved 3-0.

UTILITY REQUEST:

BSM Group is requesting install a pedestal and fiber optic along N County Line Rd, near 545 N County Line Rd., St. Paul and bore along and under W High St., S. County Line Rd, and S 750 E. Ben Taylor has asked the Commissioners to table this for a week. Taylor advised he is working with the Town of St. Paul to see if this is in the Town limits or if it is Shelby County. Motion to table was made by Lawson, seconded by Runnebohm, approved 3-0.

BSM is requesting to bore along and under E 450 S, E W 500 S, E 600 S, S 200 E, S 250E, and E 700 S. Motion to approve was made by Lawson, seconded by Runnebohm, approved 3-0.

SHERIFF:

Sheriff Koch advised the Commissioners he was looking into changing the dentist at the jail and had a new contract that John is reviewing and wanted changes. This was information only; no action was taken.
