The Shelby County Commissioners met on Monday February 10, 2025, at 8:00 a.m., and present were Commissioners Abel, Lawson, Runnebohm, County Attorney and County Auditor.

MINUTES:

Motion to approve February 3, 2025, minutes was made by Lawson, seconded by Runnebohm, approved 3-0.

ALLEY VACATION – BROOKFIELD- CENTER STREET & VINE STREET:

Ordinance 2025-2 was presented to the Commissioners to vacate two alleys located in Brookfield. The streets are Center Street and Vine Street. Motion to approve was made by Runnebohm, seconded by Lawson, approved 3-0.

SHELBY SENIOR SERVICES – SHELBY GO INVOICE:

Easter Beyer presented the Commissioners with the 2024 4th quarter request for reimbursement from the State in the amount of \$36,665.00. Motion to approve was made by Lawson, seconded by Runnebohm, approved 3-0.

COMPREHENSIVE EMERGENCY PLAN – CORONER OFFICE AMENDMENT:
