**MIKE OBERGFELL/ BRIDGE #11:**

MIKE PRESENTED THE COMMISSIONERS WITH APPRAISALS FOR BRIDGE #11 LAND ACQUISITIONS, ALL APPRAISALS WERE UNDER \$1,000.00 AND THE STATE STANDARD IS AT LEAST \$1,000.00, SO THAT IS WHAT THESE ARE FOR. THE FOLLOWING LAND OWNERS ARE: TRAVIS & RACHEL ACKLEY, BETTY JONAS TRUSTEE AND LOI FARMS, INC., MOTION TO APPROVE WAS MADE BY PARKER, SECONDED BY NIGH, APPROVED 2-0

MIKE ADVISED HE SHOULD HAVE BRIDGE #10 READY IN THE NEXT WEEK OR SO.

MIKE ALSO ADVISED THE COMMISSIONERS NEED TO DECIDE IF THEY WANT TO CONTINUE ON THE CURRENT LIST OR LOOK AT OTHER OPTIONS SINCE THE COUNTY DIDN'T RECEIVE ANY COMMUNITY CROSSING FUNDS FOR THIS YEAR. MIKE ADVISED THERE WERE A LOT OF COUNTIES THAT DIDN'T RECEIVE ANY

MONEY BECAUSE THEY RECEIVED MONEY LAST YEAR. ANDERSON ADVISED HE LOOKED INTO THIS AND THEY HAD 440 APPLICANTS AND ONLY APPROVED 285 AND OF THOSE 283 ONLY 29 WERE COUNTIES AND THE REST WERE CITIES & TOWNS. THIS WAS INFORMATION ONLY; NO ACTION WAS TAKEN.
