

THE SHELBY COUNTY COMMISSIONERS MET ON MONDAY OCTOBER 3, 2022, AT 8:00 A.M. PRESENT WERE COMMISSIONERS' NIGH, PARKER, ROSS, AND COUNTY AUDITOR

MINUTES:

MOTION TO APPROVE SEPTEMBER 26, 2022, MINUTES WAS MADE BY PARKER, SECONDED BY ROSS, APPROVED 3-0

SHERIFF:

SHERIFF GAVE AN UPDATE ON THE ELEVATORS. SHERIFF ADVISED HE HAD A MEETING WITH TK ELEVATORS AND THEY GAVE HIM RECOMMENDATIONS FOR VENDORS TO GET SOME OF THE PRE-WORK DONE. HE ALSO ADVISED THEY MAY HAVE PROBLEMS WITH THE CURRENT GENERATOR AND THEY WILL NEED TO REPLACE THE DOORS BECAUSE CODE NOW IS 1 ½ HOUR FIRE RATING. IT SHOULD TAKE 4-6 WEEKS PER ELEVATOR. THIS WAS INFORMATION ONLY.

SHERIFF KOCH ADVISED HE HAS BEEN ASKED BY ROAD DEPUTIES AND DETECTIVES IF THERE IS ANY WAY WE COULD GET WITH THE STATE AND POSSIBLY GET FLASHERS OR SOMETHING PUT UP AT STATE ROAD 9 AND OLD STATE ROAD 252. THERE HAVE BEEN NUMEROUS ACCIDENTS THERE LATELY. HE KNOWS THE STATE DID A SURVEY NOT TOO MANY YEARS AGO, BUT THE ACCIDENTS ARE BECOMING MORE FREQUENTLY. KEM ANDERSON ADVISED HE HAS A MEETING WITH THE STATE AND WILL MENTION THIS TO THEM. THIS WAS INFORMATION ONLY.

HIGHWAY:

ANDERSON ADVISED THE WORK BEING DONE ON THE CLENDENNING DITCH IS NEEDING APPROVAL FOR A ROAD CUT PERMIT. MOTION TO APPROVE THE PERMIT (NOT WAIVING THE FEE) WAS MADE BY ROSS, SECONDED BY PARKER, APPROVED 3-0
