The Shelby County Commissioners met on Monday April 10, 2023, at 8:00 a.m., present were Commissioners Nigh, Parker, Abel, County Attorney and County Auditor.

MINUTES:

Motion to approve March 27, 2023, minutes was made by Nigh, seconded by Abel, approved 3-0.

Motion to approve April 3, 2023, minutes was made by Abel, seconded by Nigh, approved 3-0.

SHELBY GO/KIM KOEHL:

Kim presented the Commissioners with a De-obligation 2022. This form just states the County has pulled down all operating and extra money, they had out for the year. Motion to approve was made by Abel, seconded by Nigh, approved 3-0

FACILITIES MANAGER/SECURITY CAMERAS :

Jose presented the Commissioners with an agreement with Koorsen for security cameras for the Court House and Annex I buildings. The total cost for Court House is \$52,897.17 and Annex is \$28,112.84. Motion to approve was made by Abel, seconded by Nigh, approved 3-0

PLAN COMMISSION/ REZONES :

Desiree presented the Commissioners with four rezones to be heard:

- Adams rezone located at 8297 S 750 E, Saint Paul requesting to rezone 6.971 acres from A1 & A2 to RE. This was heard at the March 28, 2023, meeting and voted 8-0 in favor to present to the Commissioners. Motion to approve Ordinance 2023-10 was made by Nigh, seconded by Abel, approved 3-0.
- Northwest Shelby County Reginal Sewer District is requesting to rezone 19.217 acres from A2 to IS located south of and adjoining 4875 W 600 N, Fairland. This was heard at the March 28, 2023, meeting and voted 8-0 in favor to present to the Commissioners. Motion to approve Ordinance 2023-11 was made by Nigh, seconded by Abel, approved 3-0.
- Davis rezone located at 453 E 700 S, Shelbyville requesting to rezone 14.74 acres from A2 to RE. This was heard at the March 28, 2023, meeting and voted 6-2 in favor to present to the Commissioners. Motion to approve Ordinance 2023-12 was made by Nigh, seconded by Abel, approved 3-0.
- 4. Jugaad rezone located east and adjoining 9100 N Frontage Rd, Fairland. This was heard at the March 28, 2023, meeting and voted 8-1 unfavorable to present to the Commissioners. Eric Glasco represented the Jugaads and explained this is a parking lot only for people to park their semis when they go home. This will be a paved and gated lot. People will have to pay a monthly fee to have access to the lot. No semis will be let running, this is just a place for people to leave their semi while they go home for the week or weekend. Lisa Shaler spoke against this project. Blake Newkirk read to the Commissioners the five facts and findings that were found on the project if it is allowed. Commissioner Abel asked how many jobs this project will bring to the County. Glasco advised none. Motion to deny the application was made by Abel, seconded by Nigh, approved 3-0
