

The Shelby County Commissioners met on Monday April 24, 2023, at 8:00 a.m., present were Commissioners Nigh, Parker, Abel, and County Auditor.

Commissioner Parker asked a moment of silence in remembering out county student that was killed in a vehicle accident on his way to school.

**MINUTES:**

Motion to approve April 17, 2023, minutes was made by Nigh, seconded by Abel, approved 3-0.

**COMMUNITY CORRECTIONS / IDOC GRANT:**

Josh Martin presented the Commissioners with a letter of approval for the IDCO grant for 2024. Martin advised he asked for \$590,120.19 for all salaries, but they always cut it back. Duke Energy is requesting to replace a pole near 8530 W Sycamore Rd, Fairland. Motion to approve was made by Abel, seconded by Nigh, approved 3-0.

**SHERIFF:**

Major Holder is requesting to dispose (trade) of around 100 firearms. They are replacing them with new ones. The difference in price will be being paid out of gun permit fees. Motion to approve was made by Abel, seconded by Nigh, approved 3-0.

**HIGHWAY:**

Anderson advised they have been working on the log jam on 600 N for about 3 days and it will probably take another 3 days. This was a big log jam and is going to be expensive. Diane asked for approval to pay for the log jam out of Emergency Bridge Repair. Motion to approve was made by Nigh, seconded by Abel, approved 3-0
