PCE INSURANCE/ANNUAL INSURANCE RENEWAL:

After going back and forth with the insurance company Liberty Mutual we have an overall 7% increase from last year and the total cost for the year is \$499,529.00. Jose presented the Commissioners with an agreement to add the Courthouse to add them to the current Annex I. building access control system with Koorsen. They are currently on the Sheriff's control panel and this panel is getting old and hard to find parts and people to work on it. The cost of the initial startup and a 3-year maintenance agreement is \$17,858.38. Motion to approve was made by Abel, seconded by Nigh, approved 3-0.
