The Shelby County Commissioners met on Monday July 31, 2023, at 8:00 a.m., present were Commissioners Nigh, Parker, Abel, County Attorney and County Auditor.

## **MINUTES:**

Motion to approve July 24, 2023, minutes was made by Nigh, seconded by Abel, approved 3-0.

### **RESOLUTION / HEALTH DEPT. SENATE BILL 4:**

## MAINTENANCE DEPT / FRONT LAWN LIGHTING:

Jose presented the Commissioners with a quote from Gleam Electrical for new lighting on the lawn of the Court House. This will illuminate the Flagpole, Statute and the Crosses when put out for Memorial Day. The cost is \$6,198.00. Motion to approve was made by Abel, seconded by Nigh, approved 3-0.

### **UTILITY REQUEST:**

Citizens Energy Group is requesting to install 2,850 feet of new gas line along McGregor Rd & Frontage Rd. Motion to approve was made by Abel, seconded by Nigh, approved 3-0.

### **REVIEW SOLAR ORDINANCE:**

Jason Abel presented Resolution 2023-08 putting a moratorium on Solar request from July 31, 2023, until noon on January 31, 2024, so that this ordinance 2020-26 can be reviewed. According to Purdue University Shelby County's Ordinance only has five of the recommended twelve recommendations given by the State and Purdue University.
