MINUTES:

Motion to table the minutes for December 4, 2023, was made by Nigh, seconded by Abel, approved 3-0.

OPEN BIDS FOR CCMG MORRISTOWN ROAD:

At this time, the Commissioners opened the following bids for the Morristown Road Project:

After letting Mike Obergfell review the bids, and with his recommendation, the Commissioners awarded the project to the low bidder HIS Constructors, Inc. in the amount of \$921,000.00. Motion to approve was made by Abel, seconded by Nigh, approved 3-0.

OPEN BIDS FOR THE DEMOLITION OF 47 & 59 W. HENDRICKS ST.:

At this time, the Commissioners opened the following bids for the demolition of 47 & 59 W. Hendricks Street.
