

**ORDINANCE NO. 2026 - 0<sup>2</sup>**

**AN ORDINANCE OF THE SHELBY COUNTY COUNCIL ESTABLISHING THE  
CORRECTIONAL FACILITY LIT FUND**

**WHEREAS**, Shelby County, Indiana ("County") will receive distributions of local income tax ("LIT") for correctional facilities and rehabilitation facilities under I.C. § 6-3.6-6-2.7;

**WHEREAS**, the Shelby County Council ("Council") has determined that there is a need to establish the Correctional Facility LIT Fund ("Fund"), number 1233, a non-reverting fund for the receipts and disbursement of monies received from the LIT for correctional facilities and rehabilitation facilities; and

**WHEREAS**, the Council intends to utilize the money in the Correctional Facility LIT Fund to track the receipts of the LIT for correctional facilities and rehabilitation facilities and the disbursements of the Correctional Facility LIT Fund for paying for correctional facilities and rehabilitation facilities in the County.


**NOW THEREFORE**, it is ordained by the Council as follows:


1. The Council hereby establishes a non-reverting fund known as the Correctional Facility LIT Fund (Fund 1233) into which all monies in the form of the LIT for correctional facilities and rehabilitation facilities distributions shall be deposited.
2. The Correctional Facility LIT Fund shall be used for any purpose permitted under I.C. § 6-3.3-6-2.7.
3. The County Auditor shall be responsible for the deposits and disbursements of the fund and shall keep records as to the disbursements, receipts, and current balance in such Correctional Facility LIT Fund.
4. The Auditor is directed to only disburse funds from the Correctional Facility LIT Fund upon a receipt of a claim approved by the Council.
5. Any funds placed in the Correctional Facility LIT Fund may not be withdrawn except for the purposes for which the fund was established.
6. This Ordinance shall be in full force and effect from and after its passage by the Council.






