ORDINANCE NO. 2020-05

AN ORDINANCE to amend the County Thoroughfare and Traffic Code of the County of Shelby, Indiana, by amending Article 2, Chapter 5, Section 3 as it relates to the speed limits on certain other county highways and roads and to rename portions of State Road 252.

BE IT ORDAINED by the Board of Commissioners of Shelby County, Indiana, as follows:

SECTION 1: Renaming portions of State Road 252. The portion of State Road 252 from State Road 9 to 200 West and from 250 West to the I-65 east edge of the I-65 interchange shall be renamed to Old State Road 252.

SECTION 1.5: Purpose. The purpose of this ordinance shall be to reduce below the state maximum speed limit the speed at which all vehicular traffic may travel on portions of Old State Road 252 and Flat Rock Road.

SECTION 2: Amendment of County Code. Article 2, Chapter 5, Section 3 of the County Thoroughfares and Traffic Code, referred to as SCC 2-5-3, of Shelby County, Indiana, and the ordinances heretofore adopting said section of the code are hereby amended by adding to SCC 2-5-3 a designation restricting all vehicular traffic traveling on portions of Old State Road 252 and Flat Rock Road.

SECTION 3: Substitution of Marked Designation. The following designations shall be added to SCC 2-5-3:

HIGHWAY/ROAD	PORTION AFFECTED	SPEED LIMIT
Old State Road 252	Between 300 feet east of 200 West to 200 West	45 mph
	Between 250 West to 1000 Feet west of 300 West	30 mph

Between 1000 feet west of 40 mph 300 West to 2000 feet west 300 West

Flat Rock Road Between 200 West to 1175 45 mph Feet west of 200 West

> Between 1175 feet west of 30 mph 200 West to 250 West

SECTION 4: Effective Date. This ordinance shall be in full force and effect from and after its adoption by the Board of Commissioners of Shelby County, Indiana and upon the posting of speed limit signs at appropriate positions on Old State Road 252 and Flat Rock Road at which time it shall be enforceable by all public law enforcement officers in the same manner as the enforcement of all other provisions of Article 2 of the Shelby County Code.

SECTION 5: Violations. Article 2, Chapter 5, Section 3 of the Thoroughfare and Traffic Code of Shelby County, Indiana, shall be applicable and apply to the enforcement of this ordinance.

<u>SECTION 6:</u> Repealable Provisions. All ordinances and parts of ordinances in conflict with the specific amendments herein provided are repealed.
